We work with the sector and partners to effect change by enhancing the wellbeing of individuals, organisations and communities.

VAMT has 297 members and is connected with many more through local, regional and national partnerships/networks. We are part of Third Sector Support Wales (TSSW), a partnership between Wales Council for Voluntary Action, County Voluntary Councils and Volunteer Centres throughout Wales. The collective endeavour of TSSW is to support the third sector via four key pillars of activity themed around volunteering; good governance; engagement and influencing; and sustainable funding.

Foreword by Chair and Chief Officer

We are incredibly proud to present this, the twenty-fifth Annual Report of Voluntary Action Merthyr Tydfil, for the year 2021-2022.

Our thanks go to all VAMT staff for their incredible effort throughout the year, and for also undertaking volunteering opportunities with member organisations as part of our employee volunteering scheme. We would also like to recognise and thank our Board of Trustees who remain committed to the organisation and its purpose.

Throughout the year we witnessed a reduction in the number of people volunteering as people returned to work following furlough; a very slow reopening of community venues and a cautious return to face to face meetings. We introduced a hybrid system where staff work both from home and our offices and continued to utilise digital solutions as a means of connecting with members and partners.

The year was also one of opportunity and with new service agreements via Cwm Taf Morgannwg University Health Board and Public Health Team, and also Lloyds Bank Foundation (England & Wales) we were able to expand our Team and support locally. Also, we were able to work with Merthyr Tydfil County Borough Council and bring forward an innovative grant scheme for our members which set about recognising and rewarding the extreme effort of staff, volunteers and Trustees during the pandemic.

We have been actively involved in supporting the development of a new Population Needs Assessment and Wellbeing Plan in the Cwm Taf Morgannwg region; working with WCVA colleagues towards a new 5 year Business Plan for TSSW and reviewed and revised our own Strategic Plan for the next 3 years.

This has again been a year of significance and challenge for VAMT, our members, partners and communities; a year of adjustment to 'a new normal' following the impact and effect of the pandemic in the previous year. Yet before the year is over a completely new set of challenges are about to rear their head as war between Ukraine and Russia breaks out and we enter a nationwide cost-of-living crisis. Despite this we are confident that with the support of our members and partners we will endeavour to overcome these challenges for the benefit of the County Borough and those who live and work within it.

Volunteering

Providing individuals and organisations with information and advice on volunteering and good practice is an essential area of our support. The demand for volunteers to support activities such as befriending remained high, whilst a reduction in volunteers was experienced as people returned to work following furlough. We supported a range of organisations as part of their corporate volunteering policies which was mutually beneficial for their staff and our member organisations.

Our Achievements:

- **98** volunteers received 1:1 support, information and advice in relation to volunteering.
- Helped local organisations to engage 53 volunteers in a variety of roles.
- **38** local people registered for opportunities via the Volunteering Wales website.
- 3 Volunteer Managers' Forum meetings attended by 34 members.

- 9 organisations advised on volunteer recruitment, good practice and volunteering policies.
- Administered a Youth Led Grants programme, supporting a panel of young people who awarded £5450 to 5 organisations.
- Coordinated the development of a film to highlight community response to Covid and demonstrate how volunteers, groups and schools benefitted from additional grants/ funding sourced and awarded via VAMT: https://www.youtube.com/watch?v=0B-o7WDjMJU

Good Governance

Providing information, guidance and development support on governance issues is an essential part of what we do and helps improve the skills, knowledge and expertise of those who lead community groups and voluntary organisations within Merthyr Tydfil.

Since the onset of the pandemic we have increasingly used our social media platforms as a way of disseminating information. We have a dedicated "Good Governance" section on the VAMT website which provides supportive information and tools for Trustees, and we actively promote the TSSW Knowledge Hub and its resources to benefit our members.

Our Achievements:

- **78** electronic briefings issued.
- Supporting one group to access specialist guidance.
- **9** organisations supported with setting up formally.
- One group assisted in dissolution and transfer of assets
- 1:1 support to a group on a recovery/ development plan.
- **19** attendees at **4** digital workshops for building relationships between small organisations and businesses as a non-transactional relationship.

Engagement and Influencing

We are involved in over 35 partnerships and planning groups at a local or regional level including the Regional Partnership Board and Public Service Board. We also influence national developments via TSSW.

A primary source of our engagement with members is via the range of Fora that we organise. They are themed around Health & Wellbeing; Children, Young People & Families; Volunteer Management; Befriending; Environment & Green Spaces; Food Prosperity and Funding. The Fora are identified as platforms for engaging with third sector and for influencing strategic developments.

Our Achievements:

- We arranged **53** networks/forums/learning events locally which **541** individuals attended.
- We actively supported transition of ICF funded projects to year one of the Regional Integration Fund.
- **3** sessions organised and **23** wellbeing engagement toolkits completed as part of 100 Days of Engagement to inform the Regional Population Needs Assessment and Wellbeing Plan.
- Our Community Coordinator received 266 referrals for people aged 50+ to access services and activities in the community to benefit their health and wellbeing; made 230 referrals and 293 signposts to additional community support.
- Community engagement/mapping and subsequent development of 'drop-in' advice/ support sessions for Black Asian and Minority Ethnic community members from October 2021. 8 sessions held with 41 instances of support.
- Worked with PSB partners to introduce 'Loneliness Champions' across public service organisations and created pathways of support to Community / Wellbeing Coordinators within CVCs.
- **3** editions of our 'Inform' newsletter with thematic approaches including volunteering and anti-poverty initiatives.
- We continue to develop our online presence via a range of social media platforms.
- Supporting local groups and community members to access information and advice via our dedicated officer at Calon Las Community Hub.
- We connected with the Feeding Britain coalition and agreed to develop the local Food Prosperity Network into a wider **"Feeding Merthyr Tydfil"** network with the emphasis on ensuring that by working together nobody has to go hungry or without basic essentials during the recovery from the pandemic. The Feeding Merthyr Tydfil network is the first of "Feeding Britain" developments in Wales.
- VAMT continues to lead on the **Cwm Taf Morgannwg Social Value Forum** together with BAVO and Interlink and in collaboration with the Regional Commissioning Unit, commissioned the Social Effectiveness Research Centre to undertake research into social value and measuring social value impact. The findings will be available in 2022-23.

Sustainable Funding

We continue to prioritise support for our members to ensure that they have the skills, knowledge and capacity to sustain their organisations in the recovery period. It is essential that we continue to develop strong relationships and connections with funders and statutory partners in order that our members are resilient and continue to thrive during such uncertain times.

Our Achievements:

- Following our support 36 organisations secured £1,193,609 of funding (increase of £573k on the previous year).
- VAMT administered the following 8 grant schemes, making 87 awards totalling £376,595
 - Loneliness & Isolation Grant in collaboration with MTCBC this grant will be available annually for 3 years
 - Wellbeing for Staff, Trustees and Volunteers Grant
 Scheme in collaboration with MTCBC and via Recovery
 Funding

- **Dementia Care Grant Scheme** via ICF to support people living with Dementia and their Carers.
- **Community Capacity Grant Scheme** via ICF to support priority groups including children and young people / disabilities
- **Coronavirus Recovery Grant for Volunteering** via Welsh Government to enhance volunteering in the recovery phase of the pandemic
- Mental Health Grant Scheme supporting positive mental health within the community
- Befriending Services ICF funding secured to retain services across Cwm Taf
- Third Sector Winter Pressures Fund via WCVA. Opportunity to increase capacity / services across third sector and/CVCs.
- Coordinated Quarterly Funders' Forum meetings with local and national funding bodies. Support
 also provided for the annual funding surgery of local MP and Senedd Member, with 40 people
 attending.
- Provided a range of one-to-one finance support to 4 members. We also provided an accounts and payroll service for another organisation and agreed a new contract with them for 2022-23.

New/Future Developments:

- From funding received via Cwm Taf Morgannwg Public Health Team, we hosted a 10 month full-time Black Asian Minority Ethnic (BAME) Engagement Officer from June 2021. The purpose of the role was to influence Covid-19 safe behaviours in local BAME communities.
- In Quarter 3 we signed a new Service Agreement with Cwm Taf Morgannwg UHB to support the implementation of a new regional service model supporting mental health development and service user involvement. Additional funding was secured by a separate, but related, Agreement to implement the recommendations of research into Service User and Carer experiences commissioned by the UHB in 2020.
- In Quarter 3 we appointed a Local Implementation Lead Officer via a new 12 month fixed term funding opportunity with Lloyds Bank Foundation (LBF). This post is part of their People & Communities Programme, which is delivered in 6 areas of the UK, with Merthyr Tydfil being the only Welsh area.
- VAMT worked with a number of young people and local partners to develop an application to the National Lottery Community Fund "Mind Our Future" funding aimed at supporting mental health of Children and Young People. The local application, project name Snakes & Ladders, was successful and will be led by third sector organisations, commencing in 2022-23.

RTON

- VAMT secured funding to support local social enterprises via Community Renewal Funding and sub-contracted Cwmpas (formerly Wales Co-op) to conduct the work. This included supporting
 5 social enterprises within the Borough to develop their plans. The work links directly to the 15 year Economic Recovery Plan for MTCBC.
- A collaborative bid to Welsh Government, co-written by VAMT, MTCBC and Merthyr Valleys Homes was successful. It benefits a wide range of organisations including members of the Food Prosperity Network, pre-schools and other third sector groups with financial support and will fund wider research into further sustainability for food provision. £100k secured and research will be completed in the year ahead.
